

# Uboss Fraud Protection

Our Automated Credit Locking will protect you against Toll Fraud and Bad Debt. You can configure alerts and credit thresholds against customer groups or specific users in Uboss. Take away the risk and the hassle - Uboss never sleeps.

## SUMMARY

With Uboss you are now able to credit lock individual users and customer groups. This feature is designed to protect you and your clients against Toll Fraud and Bad Debts. There are two types of credit locking; Manual Credit Lock and Automatic Credit Locking. Manual Credit locks can be activated via the T8lk Uboss Provisioning Portal, automatically barring the specific extension or all extensions within the business.

Automatic Credit Locks allows credit limits to be put against a User and/or a Business level; once this limit has been reached the account will be locked. Users will be sent an email when they have reached 90% (this default can be varied by the channel Partner) of their limit, and extra credit can then be added to their account. When a user account has been locked it will bar all devices (including Shared Call Appearance). The user will not be able to make any new calls from their extension while the lock is active, typically stopping toll fraud and hacking.

T8lk Minutes and Uboss Hosted Billing	Billing Credit Locking & Alerts	Partner may need to adjust credit limits for high spending business and or users
T8lk Minutes with CDR's exported to 3rd Party billing	Billing Credit Locking & Alerts	Partner need to populate minutes rate table in Uboss, quickest way is to just add a % uplift on T8lk rates but does mean client call charges will not be reflected accurately in the Uboss call log
3rd Party Interconnect for Minutes	Billing Credit Locking & Alerts	Partner will need to enter a pence rate with the tariff table
Batch – Imported CPS CDR's	Alerts Only	At this stage only E Mail alert available, no auto locking. Auto Locking will be available in the future if 3rd party provider can accept XML request from Uboss to lock

CDR's are rated in Uboss in real time, depending on time of day the lag can be between 15 minutes and 75 minutes. Once a credit lock has been applied it will bar any new calls from any device, including a user's Shared Call Appearance. The user will get a message informing them the extension has been barred.

When credit locking has been activated 999 calls can still be made
